Projects with an active research plan that have resulted in publication, conference presentation, and/or additional funding are especially favored. The project should demonstrate unique activity engaging the community and the University in collaborative efforts to achieve outcomes that improve the community in measurable ways. Examples include educational improvement; business, industrial development, and the economy; public understanding and adult learning; children, youth, the elderly, and the family; cultural institutions and programs

(including the arts); food, fiber, and related issues; law, governance, and public policy; health and health care; labor relations, training, and workplace safety; the environment, natural resources, and land use; public safety, security, and corrections; science, technology, engineering, and technology; human communication, including new media benefiting communities and institutions. Projects that demonstrate strong synergistic collaboration between UA students, and the community served and extend the classroom experience and maximize scholarly output will be given high priority. The project should include an assessment component, budget, and time line, and should provide evidence of how the community supports and engages in the activity. Preference will be given to projects that build capacity within communities rather than providing a one-time service.

Projects with an active research plan that have resulted in publication, conference presentation, and/or additional funding are especially favored. The project should demonstrate unique activity bringing the community and the University together in collaboration to achieve outcomes that improve the community in measurable ways. Examples include educational improvement; business, industrial development, and the economy; public understanding and adult learning; children,

youth, the elderly, and the family; cultural institutions and programs (including the arts); food, fiber, and related issues; law, governance, and public policy; health and health care; labor relations, training, and workplace safety; the environment, natural resources, and land use; public safety, security, and corrections; science, technology, engineering, and technology; human communication, including new media benefiting communities and institutions. Projects that demonstrate strong synergistic collaboration between communities external to the academy and the University in which both benefit will be given high priority. The project should include an assessment component, budget, and time line, and should provide evidence of how both the community and the University engage in the activity. Preference will be given to projects that build long-term capacity within communities rather than a one-time effort.
